APPLICATION TO VOTE BY SEALED ENVELOPE

A voter who is unable to go in person to the voting place or vote in advance, may apply in person, in writing, or by email to the senior election official at the Rural Municipality of Rosser, 77E, PR 221, Rosser Mb., R4B 0C6; email address: officeassistant1@rmofrosser.com

If applying in person*, a voter may apply between September 30 and October 25, 2026.

*A voter applying in person may pick up a sealed envelope ballot package at the time of application.

If applying by mail or email**, a voter may apply by October 25, 2026

** A voter applying by mail or email will receive a sealed envelope ballot package by regular post, or by making alternative arrangements with the senior election official.
